### NHCP Exhibit 2

### Conservation Practice Document Templates

This exhibit contains national conservation practice document (CPD) templates and establishes the conventions to be used for naming each national CPD, according to its type and subject.

CPD templates are provided in the CPD-DMS software. The templates are to be used to produce the national documents. States adopt the national documents, or create their own, using the same templates and the same naming conventions.

### Conventions for Naming CPD Files

This is the foundation of the file naming convention:

[###]\_[NHCP/StateAbbreviation]\_[Type]\_[Practice Name]-[2<sup>nd</sup> tier identifier]\_[revision year]

Underscores are always used instead of spaces in the file names.

Notes: Underscores are always used instead of spaces in the file names. Several of the file name fields are used when needed to better describe the document content.
